COUNCIL MEETING
JUNE 16, 2016
7:00 p.m.

In compliance with N.J.S.A. 10:4, Open Public Meetings Law, notice was given to two newspapers and posted, that a council meeting of the Mayor and Council was scheduled for Thursday, June 16, 2016 at 7:00 P.M. The Municipal Clerk took the roll call and showed that all were present with the exception of Councilman Whalen who gave prior notice. Also present was the Solicitor Dan Long and Engineer Mark Basehore.

A motion was made by Councilwoman Bonamassa, seconded by Councilwoman Martz to adopt the minutes of June 01, 2016 meeting with all Council voting aye.

OLD BUSINESS:

A motion was made by Councilman DePrince, seconded by Councilwoman Bonamassa to open the public hearing for Ordinance 2016:06 for the 2016 Bond Ordinance with all Council voting aye.

301 W. Evesham and all emergency responders did a great job. There was a County Emergency Management meeting. There is a new Sterling EMS Alliance coordinator Chris Ballinger.

The Mayor reported she attended the dedication of the EMS memorial at Sterling HS. She also attended to 100th graduation of the Magnolia Public School.

Councilwoman Bonamassa confirmed the County Open Space met her for inspection of the site for this year's grant application.

Councilwoman Martz reported there are 71 vacant homes and Deb Simone is doing the registration of those homes.

Councilman Krause reported the post cards for July 4th were mailed out. The laser light show will take place July 1 at Yellin School and recommended car pooling to lessen traffic issues.

Councilman Saxton reported on the AC work at the police department and the restrooms work beginning. National Night Out meeting is coming up.

The Engineer stated work the plans and bids are out for NJDOT grant funded project.

The Solicitor stated he had one legal matter for review in executive session.
