Motion made by Councilman DePrince, seconded by Councilwoman Bonamassa to adopt Resolution 2008:116 to prohibit left turns onto the White Horse Pike from Washington Avenue going west. All Council voted aye.

Motion made by Councilman DePrince, seconded by Councilwoman Bonamassa to adopt on the first reading, Ordinance 2008:13 to vacate a portion of Kings Street, south of Central Avenue. All Council voted aye by roll call vote.

Motion made by Councilman DePrince , seconded by Councilwoman Bonamassa to approve Resolution 2008:121 to allow to auction the bicycles, the red pick up truck, and the white Jeep. All Council voted aye.
