

MINUTES
COUNCIL MEETING
SEPTEMBER 01, 2010
7:00 p.m.

In compliance with N.J.S.A. 10:4, Open Public Meetings Law, notice was given to two newspapers and posted, that a council meeting of the Mayor and Council was scheduled for Wednesday, September 01, 2010 at 7:00 P.M. The Municipal Clerk took the roll call and showed that all were present with the exception of Councilman DePrince and Councilwoman Martz. The Engineer Mr. Basehore was present.

No Public was present.

Review of the agenda for the 8:00 pm session was completed.

Roundtable:

Councilman Wilson spoke of the work continuing relating to clearing the overgrowth around the perimeter of the fields at the Rec Center.

The Engineer, Mr. Basehore spoke about the traffic signal proceeding for Walmart, and the Solicitor was going to review the Developers' Agreement regarding the signal.

The Engineer also stated the change order for Charles and Madison would be at the next meeting. The slip lining for Evesham and the grinder pump installation would be completed by the end of the year.

Councilman Whalen stated the tax sale went well with all tax liens being sold.

Councilman Brandt stated the first family night noted on the town calendar had to be changed due to a conflict and would be on September 24 instead.

Motion was made by Councilman Brandt, seconded by Councilman Whalen to adopt Resolution 2010:146 for Closed Session. All Council voted aye.

Motion was made by Councilman Brandt, seconded by Councilwoman Bonamassa to come out of Closed Session, with all Council voting aye.

The 8:00 pm session began with the flag salute.

Motion was made by Councilman Brandt, seconded by Councilwoman Bonamassa to open the meeting to the public. All Council voted aye.

No one from the public spoke.

Motion was made by Councilman Whalen, seconded by Councilwoman Bonamassa to close the public portion. All Council voted aye.

Motion made by Councilwoman Bonamassa, seconded by Councilman Whalen to adopt the minutes from the August 19, 2010 meeting. All council voted aye.

No old business.

New Business:

The Mayor presented a letter of resignation from John Szczerbinski from his position of Construction Official and Building Sub-Code Official effective September 01, 2010. Motion was made by Councilman Whalen, seconded by Councilwoman Bonamassa to accept the resignation, with all of Council voting aye.

Motion made by Councilman Whalen, seconded by Councilman Brandt to adopt Resolution 2010:147 to authorize the State Contracts with Pedroni Fuel and Majestic Fuel for the year 2010. All Council voted aye by roll call vote.

Motion made by Councilwoman Bonamassa, seconded by Councilman Brandt to adopt Resolution 2010:148 to authorize the NJDOT Grant Application for Albertson Avenue. All Council voted aye by roll call vote.

Motion made by Councilman Brandt, seconded by Councilwoman Bonamassa to adopt Resolution 2010:149 to appoint to the position of Temporary Construction Official and Building Sub-Code Official Daniel Wassenar at the same rate the prior Official was being paid. All Council voted aye by roll call vote.

Motion made by Councilman Brandt, seconded by Councilman Wilson to adopt Resolution 2010:150 to appoint a DPW part time Laborer Scott Cowling at the rate of \$10.00 per hour effective August 30, 2010. All Council voted aye by roll call vote.

Councilman Whalen stated he submitted his Treasurer Report in writing.

Committee Reports:

Councilman Brandt stated he was working on the first family night for September 24, 2010 at the public school.

Councilman Wilson stated his report was submitted in writing.

Councilwoman Martz was not present but her department reports were submitted.

Councilman DePrince was absent but his court and ambulance reports were submitted.

Councilman Whalen stated his report was submitted in writing.

Councilwoman Bonamassa stated she was working on the DPW initial training and ongoing training and compliance.

The Engineer stated his report was submitted in writing.

The Solicitor stated his report was given in closed session relating to litigation.

Motion made to open the meeting to the public by Councilwoman Bonamassa, seconded by Councilman Whalen, and all Council voting aye.

No one from the public spoke.

Motion made by Councilman Brandt, seconded by Councilman Whalen, and all of Council voting aye.

Motion made by Councilman Whalen, seconded by Councilman Brandt to pay the bills as listed. All Council voted aye by roll call vote.

Motion made by Councilman Whalen, seconded by Councilwoman Bonamassa to adjourn the meeting, and all Council voted aye.
